Trustees' Annual Report for the year ended 30 June 2023

The Trustees are pleased to present their Report together with the Accounts for the year ended 30 June 2023.

Structure Governance & Management

Status of Charity and Governing Document

Society of Scottish Artists ("the charity") is a Scottish Charity (No. SC009586).

Appointment and induction of Trustees

Trustees are appointed from the members and hold office subject to an annual vote of the members at the Annual General Meeting.

Charitable objectives and activities

The Society of Scottish Artists was founded in 1891 and is an artist-run organisation, which aims to promote and encourage experimentation and "the adventurous spirit" in Scottish art. Its main space for annual exhibitions has been the Royal Scottish Academy on Princes Street in Edinburgh.

Achievements and Performance

The Society continued to grow its membership despite the unprecedented circumstances of Covid-19. Other artistic initiatives and future developments are referred to in the Presidents' report below.

President's Report

The President's Report covers the period from 1 July 2022, being the financial year covered by this Report up to 11 March 2024 being the date the Report was approved by the Trustees.

As a result it contains information on events held during the period Olivia Turner and Jamie McAteer were Co-Presidents up to 26 March 2023, the date of their retirement and also events held thereafter post the appointment (on the same date) of Vasile Toch as President.

SSA Mentoring Programme

Council members Jenny Pope and Gillian McFarland initiated and led this project successfully securing funding from Creative Scotland.

For the programme each mentor has been paired up with a mentee, which could be an artist at any stage of their career. Training has been provided for each of the mentors who are made up of established artists from across Scotland and they have been paid for their time. A steering group was established and two external professionals have been consulted during the duration of the project. During the initial discussions and formation of the 1-1 pairings, we felt it would be a fantastic opportunity to extend this and offer some group peer to peer mentoring. Doing this at the same time has given us comparable sets of data which will help us determine if we wish to continue the programme in a meaningful way, funding dependent.

Dunoon Burgh Halls (17 June – 24 July 2022)

Unmute was our first physical exhibition of the year at Dunoon Burgh Hall. This was a new collaboration for the society and was introduced by one of our satellite associates. The exhibition showcased a selection of work by SSA members in a wide range of mediums and it was great to welcome people back into the gallery space.

Drift (16 September – 16 October 2022)

Drift showcased 18 short films by SSA Members online and was curated by SSA council members Su Grierson and Lindsay Perth. The open call was a fantastic opportunity for members who may not use film in their traditional practice. The opening event was screened at Summerhall Cinema and was followed by an SSA social event.

SSA at the Big Art Show Paisley (26 August – 26 November 2022)

We were delighted to have the opportunity to support this exhibition and a new artists collective initiated in Paisley.

The SSA selected showcase featured works by nine SSA Graduate and Professional members, who were selected through an open call. Invited artist Thomas Adam exhibited a new piece of work made specifically for the exhibition to show the width and breadth of diverse work produced by our membership.

As part of the exhibition we also offered a new award in collaboration with Outspoken Arts Scotland. The Society of Scottish Artists & Outspoken Arts prize included £200 plus a 1 year's free SSA membership and was awarded to Ann Vance.

SSA 130 Years | Annual Exhibition (124th Annual Exhibition)

16 December 2022 - 10 January 2023

This year's Annual Exhibition once again took place at the Royal Scottish Academy and celebrated 130 years since the first exhibition held by the SSA at the RSA.

To celebrate, we took a unique look back at its vibrant history and wanted to showcase a selection of work that has contributed to Scotland's artistic culture. At the beginning of 2021 we started the process of organising loan agreements for works by artists who have been connected and exhibited over the 130 years. All the selected works were loaned from major institutions from across Scotland.

Works were loaned from the following Institutions: Glasgow Museums - Auguste Rodin, National Galleries of Scotland - Edvard Munch and Archive Materials, Edinburgh City Arts Centre - Francis Campbell Boileau Cadell and Bet Low, The Scottish Gallery - Joan Eardley, Abrdn - Robert Noble Wilhelmina Barns Graham Trust - Wilhelmina Barns Graham, Stirling University - George Wylie , NHS Lothian - Richard Demarco and Francis Walker, Royal Scottish Academy - Philip Reeves, Royal Scottish Academy Collections - Eduardo Paolozzi and ModernPrints.co.uk - Eduardo Paolozzi.

As part of the celebration, we invited SSA members to respond to these works and offered 10 artists an artist fee to create a contemporary response to their selected artwork.

We once again collaborated with artist-led organisation CutLog to showcase moving-image works by Scottish and international artists, responding to last year's theme, Re-imagining Wonderland. The works were screened within a new structure by artist Mike Inglis.

We were also joined by New Media Scotland to present new works by artist, designer and maker Frances Priest. Two ceramic vessels and a collaborative projection were displayed in the building's entrance.

We were also proud to celebrate artistic achievement from further afield, and the exhibition included work from international partnerships including Engramme exchange artist Nicole Schlosser, Eichstätt residency awardee Jill Bennett, and (w)ORD: EBBE+FLOW, a research residency involving artists from Scotland and Norway.

Professional Members Election

We have decided to pause this year's elections for Professional members, while we take some time to consider the implications of what this level of membership is in accordance with the constitution and the membership.

Marchmont Residency

This residency has been put on pause this year with aim to return in 2024.

The SSA had a busy period over 2023 and beginning of 2024, having organised and managed several events, as listed below:

- 1./ The Caledonian Club, exhibition, London.
- 2./ The Annual Exhibition, The Maclaurin Gallery, Ayr.
- 3./ The continuation of the mentoring programme.

The Caledonian Club Exhibition, London (21 June – 13 July 2023)

The Caledonian Club, founded in 1891 (when the SSA was also founded), is a private members' Club situated in the heart of Belgravia, adjacent to Hyde Park Corner, and it is "the representative national

club and headquarters for Scotsmen in London" as well as to those having 'close association' with Scotland.

Since the SSA approached the club in 2022, requesting the opportunity to mount an exhibition, the Board of Directors decided to launch the Revolving Exhibition programme which will open the possibility of having rolling exhibitions from a multitude of exhibitors throughout the year.

The SSA exhibition was slotted for 21 June – 13 July 2023 with the Private View on 20th of June.

Professional members of the SSA were invited to submit three artworks for consideration. The selection committee selected 28 artworks from the 107 eligible submissions.

These works, together with paintings provided by the invited artists Alasdair Wallace, were exhibited in the drawing room of the Caledonian Club.

The exhibition could only be attended by appointment.

It was noted that John Howard, former Prime Minister of Australia visited the exhibition on 27th of June.

2. The 125th Annual Exhibition, The Maclaurin Gallery, Ayr (19 November 2023 – 14 January 2024) Exhibition title: "SSA- art for the people"

The SSA 125th annual exhibition, 18th November 2023 – 14 January 2024, was held at The Maclaurin Gallery in Ayr, marking a pivotal moment in the trajectory of the society.

Part of the historic Rozelle house complex in Ayr, the Maclaurin Gallery holds one of the best national collections of 20th and 21st century art, including works by John Bellany, Alan Davie, Patrick Heron, William McCance and Bridget Riley. The gallery's patron, Peter Howson OBE, is one of Scotland's leading contemporary painters.

Exhibiting at The Maclaurin gallery in Ayr, away from our usual venue at the Royal Scottish Academy in Edinburgh, represents the beginning of our efforts towards expanding our presence across all Scottish regions and the rest of the UK, with the intention of bringing the best of contemporary Scottish visual arts to the larger public, to be followed by similar events across the country over the coming years.

The selection process was coordinated by Vasile Toch, the newly elected President, along Vice-Presidents Carolyne Nurse and Frank To and a Selection Committee of a further three members from the wider membership, with commendable help from SSA Council and volunteers.

We had 1229 entries (open call) for this exhibition, with local, national, and international contributions.

The 125th Annual Exhibition presented 134 artworks, covering a variety of approaches and disciplines including printmaking, painting, sculpture, and installation, together with a selection of works by our guest artist Peter Howson OBE.

The exhibition had the support of Clare Adamson MSP and Professor Richard Demarco.

Bringing this important event to Ayr was received very well by the local institutions, local public and Ayrshire based artists, with press coverage in Scottish Field (31/10/23), Artmag (10/11/23), The Scotsman (17/11/23), The Herald (18/11/23), The Sunday Post (19/11/23), The Times Scotland (21/11/23), The Ayrshire Post (22/11/23), The Fleming Collection.

CutLog | Viewpoint (19 November 2023 – 14 January 2024)

We have also collaborated with CutLog for the fourth time, to present a series of works entitled *Viewpoint* for our 125th Annual Exhibition.

<u>CutLog</u> is a group of artists in Scotland who have come together to create new opportunities for movingimage artists.

This year Moving Image Artists from the SSA membership were invited to submit moving image works under 10 minutes long in response to the theme *Viewpoint*.

Exhibiting artists: Ally Wallace, Oana Stanciu, Luis Grane, Olana Light, Chak Hin Leung, Su Grierson, Pat Law, Collette Rayner, Holger Mohaupt, Pernille Spence and Zoe Irvine, Mike Inglis.

The 11 selected works were shown in a dedicated room via single screen, large scale projection, and will also be available to view on the SSA website after the exhibition. The works range from performance, environmental responses to documentation of the human environment, from hand-drawn and digital animation, through locations that range from Glasgow, Venice, Svalbard, Indonesia and Los Angeles.

SSA Graduate Awards 2023

This year's degree shows offered such exciting and high-quality work that the SSA selectors have increased the number of awards to 12 and also added a new category of Highly Commended which was awarded to three new graduates.

We were pleased to see such ambitious and diverse work across the six campuses ranging from pin-hole photography to spoken word performance. It is a privilege not only to see the work of the next generation of artists but also to share it with our audiences in our 125th exhibition.

30 x 30 Online Exhibition (18 November 2023 – 14 January 2024)

Our popular 30×30 small works display returned as an online presentation to accompany our 125th Annual Exhibition at the Maclaurin Art Gallery in Ayr. 30×30 online offered a fantastic, varied selection of small works by SSA Members for sale at affordable prices.

Lectures and guided tours

At the end of our 125th Annual exhibition we presented a very important lecture, "Ukraine: the role of culture at a time of war".

The lecture was delivered by Giles Hansen Sutherland, freelance academic and journalist. The lecture was followed by a dynamic Q&A session with contributions from Richard Demarco, Vasile Toch, Oleksandra Novatska and two unidentified artists.

Vasile Toch led a guided tour of the exhibition on the 8th of January, for the benefit of the local Ayrshire Art Society.

Extra prizes

Clare Henry, the art critic, visited the exhibition and very generously offered a new award, "the Clare Henry Prize". Received with thanks.

3. SSA Mentoring Programme

The SSA highly successful Mentoring scheme ended in 2023 with an exhibition and presentation at Cass Arts in Glasgow. Many thanks to Gillam McFarland, Jenny Pope and Vibha Pankaj for their efforts. Connect + Grow, an exhibition celebrating the SSA Mentoring Programme, took place at Cass Art in Glasgow from 18-29 November 2023.

It was an opportunity to bring together many of the programme's participants for the first time, with some working collaboratively and others individually to talk about their experiences and their journey,

as mentors and mentees, over the past year.

In response to the mentoring programme, some of the work on show focused on experimentation and moving out of comfort zones, while other work demonstrates moments of confidence and new found clarity. The exhibited work, from paintings to artist's books, and digital prints to collage, gives a sense of the range of artists from across Scotland who have participated in the programme.

Financial Review

Results for the Year

The charity's *Statement of Receipts and Payments* reflect a Deficit for the year of £25,824 (2022 – Surplus £22,702).

Reserves Policy

The Trustees' policy is to maintain unrestricted funds at a level equating to at least approximately three months of unrestricted expenditure and thereby help to maintain the charity's ongoing work. Per the *Statement of Balances*, the General Fund at 30 June 2023 amounted to £49,467 (2022 - £60,866) which, although above the required level, was acceptable to the Trustees. Total Reserves, including Restricted Funds, are £54,616 as at 30 June 2023.

Risks to which the charity is exposed

The trustees consider that due to its small size and its simplicity there is no material risk to which it is exposed. The situation is reviewed at each meeting. A principal concern is the annual charge by the National Gallery of Scotland (NGS) for use of the RSA, which is the most significant cost that the Society incurs. We are grateful to The Exhibiting Societies of Scottish Artists (ESSA) for liaising with NGS in order to agree the terms of our use of the RSA.

Statement of Trustees' Responsibilities

The Trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the charity's financial position and enable them to ensure that the Accounts comply with the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 (as amended) and the provisions of the charity's Constitution. They are responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

The Trustees are also responsible for the contents of the trustees' report and the responsibility of the independent examiner in relation to the trustees' report is limited to examining the report and ensuring that, on the face of the report, there are no inconsistencies with the figures disclosed in the financial statements.

Notes to the Accounts for the year ended 30 June 2023

1. Basis of Accounting

The Accounts have been prepared on a Receipts and Payments basis in accordance with the Charities and Trustees Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended).

Funds

For the purpose of the *Statement of Receipts and Payments* and the *Statement of Balances,* Funds comprise the following:

The General Fund comprises grants and other income received for use at the discretion of the Directors in furtherance of the charity's purposes.

Restricted Funds are subject to specific conditions by donors as to how they may be used. The purposes and uses of the Restricted Funds are set out below.

2. Going Concern

The charity is a going concern and is heavily dependent on the continuing support of its subscribing members, both professional and lay.

3. Taxation

As a registered charity, the society is exempt from income and corporation tax to the extent that its income and gains are applicable to charitable purposes only. Value Added Tax is not recoverable by the society and is therefore included in any relevant costs.

If upon winding up or dissolution of the charity there remain any assets, after the satisfaction of all debts and liabilities, the assets represented by the accumulated fund shall be transferred to some other charitable body or bodies having objects similar to those of the charity.
